POC Due Date: 03/12/2025 (1), Based on Observation and Interview, the Licensee Did Not Comply with the Section Cited Above as Facility Did Not Ensure Children's Bedding Did Not Come Into Contact with One Another as Blankets and Bedding From Different Children Were Seen Touching One Another Due to Being Placed Together in a Hamper Which Poses a Potential Health, Safety or Personal Rights Risk to Persons in Care.
