Across 1 inspection since 2024, the issues cited most often were Associated with Complaint 591-1-1-.03(8) Requires a Center to Provide Individual Attention to Each Child by Responding Promptly to the Child's Distress Signals and Need for Comfort. It Was Determined Based on an Investigation That on January 19, 2024, a Six-year-old Child Fell While Attending the After School Program. Staff Members Failed to Respond Promptly to the Needs of the Six-year-old Child (1), Associated with Complaint 591-1-1-.29(3) Requires the Director or Designated Person-in-charge to Report or Cause to Be Reported to the Department Within Twenty-four (24) Hours or the Next Work Day: Any Death of a Child While in the Care of the Center (1), and Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (1). None of the 3 findings were critical.
