Across 2 inspections since 2026, the issues cited most often were Associated with Complaint 591-1-1-.03(9) Requires Center Staff to Refrain From Engaging In, or Allowing Children or Other Adults to Engage In, Activities That Could Be Detrimental to a Child's Health or Well-being, Such as but Not Limited To, Horse Play, Rough Play, Wrestling, and Picking Up a Child in a Manner That Could Cause Injury. It Was Determined Based on an Investigation That on March 10, (1), Associated with Complaint 591-1-1-.29(3) Requires the Director or Designated Person-in-charge to Report or Cause to Be Reported to the Department Within Twenty-four (24) Hours or the Next Work Day: Any Death of a Child While in the Care of the Center (1), and Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (1). None of the 5 findings were critical.
