Across 4 inspections since 2023, the issues cited most often were 591-1-1-.26(4) Requires That Playgrounds Be Protected From Traffic or Other Hazards by a (4) Four Foot High Fence or Other Barrier Approved by This Department. Fencing Material Shall Not Present a Hazard to Children and Shall Be Maintained So as to Prevent Children From Leaving the Playground Area by Any Means Other Than Through an Approved Access Route. Fence Gates Shall Be Kept Closed Except Whe (2), 591-1-1-.09(1)(c) Requires the Center to Ensure That Every Employee Has a Valid and Current Satisfactory Comprehensive Records Check Determination on File Prior to Being Present at the Center While Any Child Is Present for Care or Before an Individual Age 17 or Older Resides in the Center. The Comprehensive Records Check Determination Must Have a Records Check Clearance Date That Is No Older Than (1), and 591-1-1-.14(1) Requires the Center Director And, at Any Given Time, at Least Fifty Percent (50%) of the Caregiver Staff to Successfully Complete a Biennial Training Program in Cardiopulmonary Resuscitation (CPR) and a Triennial Training Program in First Aid. The First Aid Training Must Be Done by Certified or Licensed Health Care Professionals or Trainers and Must Deal with the Provision of Emerge (1). None of the 5 findings were critical.
