It Was Determined Based on Observation That the Following Rooms Did Not Hav (2), 591-1-1-.25(14) Requires the Center to Be Lighted with a Minimum of Twenty-five Foot Candles of Illumination Except During Rest Periods. Areas Used for Napping Shall Be Lit Dimly. It Was Determined Based on Observation That the Following Items Needed Repair: 2L- One Light Was Not Working and Missing the Cover 3L- Two Lights Were Not Working 1R- One Light Was Not Working and Missing Light Cover 1L- (1), and Discussed Maintenance of Resilient Surface. Please Fluff and Redistribute. Finding 591-1-1-.26(6) Requires That Playground Equipment Provide an Opportunity for the Children to Engage in a Variety of Experiences and Shall Be Age-appropriate. For Example, Toddlers Shall Not Be Permitted to Swing in Swings Designed for School-age Children. The Outdoor Equipment Shall Be Free of Lead-based Paint, Shar (1).
