It Was Determined Based on an Investigation That Staff Failed to Keep Three 3-year-old Children Clean, Dry, and Comfortable When the Children Had Removed Their Clothing and Chased Each Other Around While Outside. (1), 591-1-1-.08(1) Requires the Center Staff to Maintain a File for Each Child While Such Child Is in Care and for One Year After That Child Is No Longer Enrolled. In Order for the File to Be Complete, the File Shall Contain the Following: Child's Name, Birth Date, Sex, Address, Living Arrangement, Name of School if Applicable (1), and Discussed Maintenance of Resilient Surface.
