Across 2 inspections since 2023, the issues cited most often were 591-1-1-.26(9) Requires the Playground to Be Kept Clean, Free From Litter and Free of Hazards, Such as but Not Limited to Rocks, Exposed Tree Roots and Exposed Sharp Edges of Concrete. It Was Also Determined Based on Observation That Tree Stumps on the Playground, Under the Tree Located to the Left of the Play Area Were Present and Posing a Tripping Hazard. (2), 591-1-1-.20(3) Requires the Center to Maintain a Record of Medication Dispensed That Includes the Date, Time and Amount of Medication, Any Noticeable Adverse Reaction, and the Signature or Initials of the Person Administering the Medication. It Was Determined Based on Observation That the Medication Records Were Incomplete. (1), and 591-1-1-.36(4)(a) Requires an Annual Safety Check for Each Vehicle. The Annual Safety Check, Completed by a Trained Individual, Should Include a Check of The: Tires, Headlights, Horn, Taillights, Turn Signals, Brake Lights, Brakes, Suspension, Exhaust System, Steering, Windows, Windshields and Windshield Wipers. A Copy of the Annual Safety Check Will Be Kept in the Center or on the Vehicle and Sho (1). None of the 5 findings were critical.
