Across 2 inspections since 2024, the issues cited most often were 91-1-1-.33(5) Requires That Every Calendar Year After the First Year of Employment, All Supervisory and Caregiver Personnel, Except Independent Contractors, Students-in-Training and Volunteers Shall Attend Ten (10) Clock Hours of Diverse Training Which Is Task-focused in On-going Health, Safety and Early Childhood or Child Development Related Topics and Which Is Offered by an Accredited College, U (1), 591-1-1-.16(f) Requires the Center to Submit an Application for an Amended License at Least 30 Days Prior to a Change if There Is a Change in the Name of the Program or Center, Changes in the Ages of the Children to Be Served, an Increase in the Regular Hours of Operation Such That the Center Would Be Providing Evening or Night- Time Care in Addition to Day-time Care, Changes in the Services Provi (1), and 591-1-1-.21(3) Requires That the Center Conduct Drills for Fire, Tornado and Other Emergency Situations.
