Across 2 inspections since 2025, the issues cited most often were 591-1-1-.06(4) Requires a Center First Licensed After March 1, 1991, and Centers That Remodel or Add to Existing Plumbing Facilities, to Have the Bathroom Area Fully Enclosed and Ventilated to the Outside of the Building with Either an Open Screened Window or Functioning Exhaust Fan and Duct System and Requires Centers Without Fully Enclosed Bathrooms to Ensure There Is Adequate Ventilation to Con (1), 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members Are Physically Present in T (1), and Associated with Investigation 591-1-1-.29(3) Requires the Director or Designated Person-in-charge to Report or Cause to Be Reported to the Department Within Twenty-four (24) Hours or the Next Work Day: Any Death of a Child While in the Care of the Center (1). None of the 4 findings were critical.
