Across 2 inspections since 2025, the issues cited most often were 591-1-1-17(7) Requires That Children Wash Their Hands with Liquid Soap and Warm Running Water Upon Arrival for Care, When Moving From One Child Care Group to Another, Upon Re-entering the Child Care Area After Outside Play, Before and After Eating Meals and Snacks, Handling or Touching Food, Playing in Water (1), Please Ensure the Cots in Room 3 Are Covered. (1), and 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members Are Physically Present in T (1). None of the 5 findings were critical.
