Fencing Material Shall Not Present a Hazard to Children and Shall Be Maintained So as to Prevent Children From Leaving the Playground Area by Any Means Other Than Through an Approved Access Route. Fence Gates Shall Be Kept Closed Except Whe (2) and 591-1-1-.30(2)(c) Requires That Infants Shall Not Sleep in Equipment Other Than Safety-approved Cribs, Such As, but Not Limited To, a Car Safety Seat, Bouncy Seat, Highchair, or Swing. Infants Who Arrive at the Center Asleep or Fall Asleep in Such Equipment, on the Floor or Elsewhere, Shall Be Transferred to a Safety-approved Crib.
