Across 1 inspection since 2026, the issues cited most often were 591-1-1-.12(2) Requires That All Equipment and Furniture Be Free From Hazardous Conditions Such As, but Not Limited To, Sharp Rough Edges or Toxic Paint (1), 591-1-1-.06(7) Requires Center Staff to Ensure Bathrooms Are Cleaned Daily with a Disinfectant. It Was Determined Based on Observation That There Were Two Toilets with Standing Feces and Two Toilets with Black Rings Present. In Addition, There Were Many Toilets with Dirt and Debris Present on the Toilet. (1), and Please Secure Cleaning Tools (I.e., Broom, Plunger) Out of Reach of Children. Technical Assistance The Consultant Discussed with the Director to Ensure Any Area Rugs Present Were Not Bunched Up or Creased So That a Tripping Hazard Was Not Posed. (1). None of the 4 findings were critical.
