Across 4 inspections since 2024, the issues cited most often were 290-2-3-.07(8)(a) Requires the Home to Maintain for the Provider and Any Provisional Employee or Employee with Direct Care Responsibilities Current Evidence of Successful Completion of a Biennial Training Program in Pediatric Cardiopulmonary Resuscitation (CPR) and a Triennial Training Program in Pediatric First Aid Which Have Been Offered by Certified or Licensed Health Care Professionals or Trai (3), 290-2-3-.13(2)(a) Requires That Outdoor Play Areas Be Kept Clean and Free of Hazards Such as Exposed Sharp Corners of Concrete or Equipment, Rust and Splinters on Equipment, Broken Glass, Open Drainage Ditches, Holes and Stagnant Water. It Was Determined Based on Observation That the Central Air Unit Located in the Outside Play Area Accessible to Children Was Not Enclosed. Georgia Department of Ea (1), and 290-2-3-.21(1)(a) Requires the Home to Ensure That the Provider, Every Actual and Potential Employee(including Residents Age 17 and Older) and Provisional Employee of the Family Child Care Learning Home Has Submitted Both a Records Check Application to the Department and Fingerprints to an Authorized Fingerprinting Site. It Was Determined Based on a Review of Records That Staff Member # 2 and Staf (1). None of the 5 findings were critical.
