Such Records Shall Include: Identifying Information (Child's Name, Birth Date, Parent's Name, Home and Business Addresses, Telephone Numbers) (2) and 290-2-3-.07(16) Requires the Home to Ensure That the Total Number of Children Not Related to the Provider in the Family Child Care Learning Home, for Pay or Not for Pay, Cannot Exceed Six Children, Except That a Provider May Care for Two Additional Children Who Are Three Years of Age or Older for Two Designated One Hour Periods Daily Upon Approval by the Department.
