Across 3 inspections since 2024, the issues cited most often were 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members Are Physically Present in T (1), 591-1-1-.08(1) Requires the Center Staff to Maintain a File for Each Child While Such Child Is in Care and for One Year After That Child Is No Longer Enrolled. In Order for the File to Be Complete, the File Shall Contain the Following: Child's Name, Birth Date, Sex, Address, Living Arrangement, Name of School if Applicable (1), and 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. Room F: Broom and Dust Pan Accessible Near the Water Fountain. Also, the Staff Bathroom Was Unlocked and the Toi (1). None of the 5 findings were critical.

Before a Change of Occupant, Each Mattress Shall Be Cleaned with a Disinfectant. It Was Determined Based on Observation of Consultant That Four Crib Mattresses Out of Eight Mattresses Were Not Two Inches Thick.**
