Across 5 inspections since 2025, the issues cited most often were 591-1-1-.14(2)(b) Requires That There Must Always Be One Staff Person Present in Each Classroom Where Children Are Present That Has Current and Valid Pediatric Cardiopulmonary Resuscitation (CPR) and Pediatric First Aid Training. It Was Determined Based on Observation That Staff # 2 Was Supervising Six 1-year-old Children During Nap Without Having a Current and Valid Pediatric Cardiopulmonary Resu (1), Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (1), and Associated with Complaint 591-1-1-.31(13) Prohibits Center Staff From Committing Any Criminal Act, as Defined Under Georgia Law, in the Presence of Any Child Enrolled in the Center and Requires Center Staff to Comply with All Applicable Laws and Regulations. It Was Determined Based on an Investigation That on September 8, 2025, a Staff Person Did Not Comply with All Applicable Laws and Regulations (1). None of the 5 findings were critical.
