Across 2 inspections since 2024, the issues cited most often were 591-1-1-.36(4)(f)1. Requires That All Transported Children Be Secured in a Child Passenger Restraining System or Seat Safety Belt in Accordance with Current State and Federal Laws and Regulations and According to Manufacturer's Directions. It Was Determined Based on Observation That the Fifth Left Aisle Seatbelt Was Observed to Be Fraying. (2), 591-1-1-.26(4) Requires That Playgrounds Be Protected From Traffic or Other Hazards by a (4) Four Foot High Fence or Other Barrier Approved by This Department. Fencing Material Shall Not Present a Hazard to Children and Shall Be Maintained So as to Prevent Children From Leaving the Playground Area by Any Means Other Than Through an Approved Access Route. Fence Gates Shall Be Kept Closed Except Whe (1), and 591-1-1-.14(2) Requires a Staff Member Who Is Trained in CPR and First Aid to Be on the Premises and on Any Field Trip Whenever Any Child Is Present. In Addition, Staff Who Provide Direct Care to Children Must Satisfactorily Obtain Certification in First Aid and CPR by December 29, 2016 if Employed Prior to September 30, 2016 and Within 90 Days of Their Hire Date if Employed After September 30, 20 (1).
