Across 2 inspections since 2025, the issues cited most often were 290-2-3-.07(8)(a) Requires the Home to Maintain for the Provider and Any Provisional Employee or Employee with Direct Care Responsibilities Current Evidence of Successful Completion of a Biennial Training Program in Pediatric Cardiopulmonary Resuscitation (CPR) and a Triennial Training Program in Pediatric First Aid Which Have Been Offered by Certified or Licensed Health Care Professionals or Trai (2), 290-2-3-.08(12) Requires That Documentation for the Care of Related Children in the Home, Other Than the Providers Own Children, Include a Notarized Statement of Family Relationships by the Parent(s).
