Across 2 inspections since 2024, the issues cited most often were Associated with Complaint 591-1-1-.07(2) Requires That Parents Be Immediately Notified and Specific Instructions Obtained Until the Child Can Be Picked Up or Returned to the Group, Immediately When Professional Medical Attention Is Required, or When the Child Experiences Symptoms of Moderate Discomfort, or When the Child Is Involved in an Incident That Puts Their Health And/or Safety at Risk and T (1), Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (1), and 591-1-1-.09(1)(l)3. Requires the Center to Immediately Require a New Comprehensive Records Check Determination for a Director, Employee or Provisional Employee at Least Once Every Five Years.
