Across 3 inspections since 2024, the issues cited most often were 591-1-1-.14(1) Requires the Center Director And, at Any Given Time, at Least Fifty Percent (50%) of the Caregiver Staff to Successfully Complete a Biennial Training Program in Cardiopulmonary Resuscitation (CPR) and a Triennial Training Program in First Aid. The First Aid Training Must Be Done by Certified or Licensed Health Care Professionals or Trainers and Must Deal with the Provision of Emerge (1), 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. It Was Determined Based on Observation the Following Hazards Were Accessible to Children: Classroom E (Infants) - One Bottle of Clorox and One Container of Lysol Cleaner and Toilet Brush Was Observed Stored in a Low, Unlocked Cabinet, Accessible to Children. CI (1), and 591-1-1-.20(1) Requires Personnel to Obtain Specific Written Authorization From the Child's Physician or Parent in Order to Dispense Prescription or Non-prescription Medications, Except for First Aid. Such Authorization Will Include When Applicable, Date (1). None of the 5 findings were critical.
