Across 2 inspections since 2025, the issues cited most often were 591-1-1-.19(1) Requires a Center to Provide 35 Square Feet of Usable Space per Child, Which Will Determine the Center's License Capacity. It Was Determined Based on Observation That in Room E, the Center Housed 11 Children in a Space That Was Licensed for 10. It Was Further Determined That the Center Housed 19 Children in a Space That Was Licensed for 16. (2), 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. It Was Determined Based on Observation That in the 4-year-old Room, a Pair of Adult Scissors, a Knife, and Hand Sanitizer Were Stored on a Shelf and Accessible to Children. (1), and 591-1-1-.26(6) Requires That Playground Equipment Provide an Opportunity for the Children to Engage in a Variety of Experiences and Shall Be Age-appropriate. For Example, Toddlers Shall Not Be Permitted to Swing in Swings Designed for School-age Children. The Outdoor Equipment Shall Be Free of Lead-based Paint, Sharp Corners and Shall Be Regularly Maintained in Such a Way as to Be Free of Rust And (1). None of the 5 findings were critical.
