Across 3 inspections since 2024, the issues cited most often were Previously Cited: 91-1-1-.33(5) Requires That Every Calendar Year After the First Year of Employment, All Supervisory and Caregiver Personnel, Except Independent Contractors, Students-in-Training and Volunteers Shall Attend Ten (10) Clock Hours of Diverse Training Which Is Task-focused in On-going Health, Safety and Early Childhood or Child Development Related Topics and Which Is Offered by an Acc (2), 591-1-1-.26(9) Requires the Playground to Be Kept Clean, Free From Litter and Free of Hazards, Such as but Not Limited to Rocks, Exposed Tree Roots and Exposed Sharp Edges of Concrete. It Was Determined Based on Observation That a Black Hose Was Observed to Be Unraveled in the Right Corner of Playground A Upon Exiting the Office. Also on Playground B, a Rock Was Observed to Be Exposed on the Area (1), and 591-1-1-.14(2) Requires a Staff Member Who Is Trained in CPR and First Aid to Be on the Premises and on Any Field Trip Whenever Any Child Is Present. In Addition, Staff Who Provide Direct Care to Children Must Satisfactorily Obtain Certification in First Aid and CPR by December 29, 2016 if Employed Prior to September 30, 2016 and Within 90 Days of Their Hire Date if Employed After September 30, 20 (1). None of the 5 findings were critical.
