Across 5 inspections since 2024, the issues cited most often were 591-1-1-.09(1)(a) Requires That a Center Ensure That Every Actual and Potential Director, Employee and Provisional Employee of a Child Care Learning Center Submit Both a Records Check Application to the Department and Fingerprints to an Authorized Fingerprinting Site. It Was Determined That the Director Present at the Facility Lacked a Current Criminal Records Check.
