### 3 Inspection Visits Since 2024 - 5 Findings

● 5 Important

Across 3 inspections since 2024, the issues cited most often were Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (1), 591-1-1-.12(1) Requires Each Employee and Child in Attendance to Use All Indoor and Outdoor Furniture, Activity Materials, and Equipment in a Safe and Appropriate Manner and in Accordance with the Manufacturer's Instructions, Recommendations, and Intended Use. All Equipment and Furniture Shall Be Used Only by the Age- Appropriate Group of Children. It Was Determined Based on Observation That a One (1), and 591-1-1-.10(4) Requires That if Diapers Are Changed on a Diaper Changing Surface, the Surface Shall Be Smooth, Nonporous, and Equipped with a Guard or Rails to Prevent Falls. Between Each Diaper Change, the Diaper Changing Surface Shall Be Cleaned with a Disinfectant and Dried with a Single-use Disposable Towel. It Was Determined Based on Observation That a Staff Member Did Not Clean the Changing (1). None of the 5 findings were critical.
