Across 3 inspections since 2025, the issues cited most often were 591-1-1-17(7) Requires That Children Wash Their Hands with Liquid Soap and Warm Running Water Upon Arrival for Care, When Moving From One Child Care Group to Another, Upon Re-entering the Child Care Area After Outside Play, Before and After Eating Meals and Snacks, Handling or Touching Food, Playing in Water (2), Associated with Complaint 591-1-1-.03(9) Requires Center Staff to Refrain From Engaging In, or Allowing Children or Other Adults to Engage In, Activities That Could Be Detrimental to a Child's Health or Well-being, Such as but Not Limited To, Horse Play, Rough Play, Wrestling, and Picking Up a Child in a Manner That Could Cause Injury. It Was Determined Based on an Investigation That on April 11, (2), and Associated with Complaint 591-1-1-.11(2) Requires That Personnel Not: Physically or Sexually Abuse a Child or Engage or Permit Others to Engage in Sexually Overt Conduct in the Presence of Any Child Enrolled in the Center (1).
