Across 4 inspections since 2025, the issues cited most often were 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. It Was Determined Based on Observation That in Classroom # 6, and Classroom #7 Were Black Computer Cords in the Top Drawer Unlocked Accessible to Children. It Was Further Observed in Classroom # 9 Two Plastic Grocery Bags in the Top Drawer Near the Changing Tab (2), Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (2), and Associated with Investigation 591-1-1-.03(9) Requires Center Staff to Refrain From Engaging In, or Allowing Children or Other Adults to Engage In, Activities That Could Be Detrimental to a Child's Health or Well-being, Such as but Not Limited To, Horse Play, Rough Play, Wrestling, and Picking Up a Child in a Manner That Could Cause Injury.
