Across 3 inspections since 2025, the issues cited most often were Associated with Complaint 591-1-1-.03(9) Requires Center Staff to Refrain From Engaging In, or Allowing Children or Other Adults to Engage In, Activities That Could Be Detrimental to a Child's Health or Well-being, Such as but Not Limited To, Horse Play, Rough Play, Wrestling, and Picking Up a Child in a Manner That Could Cause Injury. It Was Determined Based on Investigative Findings That on Marc (1), A Variety of Equipment and Toys Were Observed Throughout the Center on This Date. Finding 591-1-1-.12(2) Requires That All Equipment and Furniture Be Free From Hazardous Conditions Such As, but Not Limited To, Sharp Rough Edges or Toxic Paint (1), and Associated with Investigation 591-1-1-.07(2) Requires That Parents Be Immediately Notified and Specific Instructions Obtained Until the Child Can Be Picked Up or Returned to the Group, Immediately When Professional Medical Attention Is Required, or When the Child Experiences Symptoms of Moderate Discomfort, or When the Child Is Involved in an Incident That Puts Their Health And/or Safety at Risk A (1).
