Across 2 inspections since 2024, the issues cited most often were Director Provided 1 File(s) for Employees Hired Since Last Visit on October 8, 2024. Finding 591-1-1-.09(1)(c) Requires the Center to Ensure That Every Employee Has a Valid and Current Satisfactory Comprehensive Records Check Determination on File Prior to Being Present at the Center While Any Child Is Present for Care or Before an Individual Age 17 or Older Resides in the Center. The Comprehensive (1), 591-1-1-.14(2)(a) Requires That When Any Child Is Present on the Premises, at Least Fifty Percent (50%) of the Caregiver Staff Present Shall Be Trained in Pediatric Cardiopulmonary Resuscitation (CPR) and Pediatric First Aid. It Was Determined Based on a Review of Records That Six of 17 Employees Had Evidence of CPR/First Aid Certification. (1), and 591-1-1-.25(14) Requires the Center to Be Lighted with a Minimum of Twenty-five Foot Candles of Illumination Except During Rest Periods. Areas Used for Napping Shall Be Lit Dimly. Not All Rooms Were Appropriately Illuminated When the Boys Rest Room in Pre-k 3 Was Observed to Be Inoperable. (1). None of the 3 findings were critical.
