Across 4 inspections since 2023, the issues cited most often were Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (1), 591-1-1-.36(4)(c) Requires That Each Vehicle Be Equipped with a Fire Extinguisher Maintained in Working Order and Kept Inaccessible to Children. It Was Determined Based on Observation, the Center Vehicle Was Not Equipped with a Fire Extinguisher. It Was Determined Based on an Investigation That on an Unknown Date in January 2023, Center Staff Taped a One-year-old Child's Shoes to Their Feet to Prevent Them From Coming Off.**
