It Was Determined Based on Review of Staff Records That Staff Member #6, with a Hire Date of 04/28/2025, Did Not Submit Both a Reco (2), 591-1-1-.12(4) Requires That Equipment and Furniture Is Secured if It Is of a Weight or Mass That Could Cause Injury From Tipping, Falling, or Being Pulled or Pushed Over. It Was Determined Based on Observation That Five Cafeteria Tables on Wheels Were Closed, Standing in the Upright Position in the Cafeteria Where 75 Children Were Present and Had Access to Them on This Date.
