It Was Determined Based on Observation That the TV in Room C, B, and the Right Front Were Not Mounted and Posed a Tipping Hazard. (2), 591-1-1-.14(2)(b) Requires That There Must Always Be One Staff Person Present in Each Classroom Where Children Are Present That Has Current and Valid Pediatric Cardiopulmonary Resuscitation (CPR) and Pediatric First Aid Training. It Was Determined That Staff # 5 Was Present in Classroom D Left Back Without a Current and Valid CPR and Pediatric First Aid Training as Required.
