Across 4 inspections since 2025, the issues cited most often were Associated with Complaint 591-1-1-.03(9) Requires Center Staff to Refrain From Engaging In, or Allowing Children or Other Adults to Engage In, Activities That Could Be Detrimental to a Child's Health or Well-being, Such as but Not Limited To, Horse Play, Rough Play, Wrestling, and Picking Up a Child in a Manner That Could Cause Injury. It Was Determined That There Was Sufficient Evidence To. Suppo (1), 591-1-1-.14(1)(a) Requires All Staff Who Provide Direct Care to Children Must Obtain Certification in a Biennial Training Program in Pediatric Cardiopulmonary Resuscitation (CPR) and a Triennial Training Program in Pediatric First Aid Within the First 45 Days of Employment.
