Across 3 inspections since 2023, the issues cited most often were 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members Are Physically Present in T (2), 591-1-1-.26(3) - Reminder to Replace Shade Tarps on Both Playgrounds That Was Damaged in Hurricane Helene.
