Across 3 inspections since 2024, the issues cited most often were 591-1-1-.26(9) Requires the Playground to Be Kept Clean, Free From Litter and Free of Hazards, Such as but Not Limited to Rocks, Exposed Tree Roots and Exposed Sharp Edges of Concrete. It Was Determined Based on Observation That Multiple Pieces of Wood Under the Brown Boards That Enclosed Equipment on Three Playgrounds Had Rot Present and Needed to Be Replaced. Further, the Concrete Was Broken By (1), 591-1-1-.25(3) Requires the Center and Surrounding Premises to Be Kept Clean, Free of Debris and in Good Repair.
