Across 2 inspections since 2025, the issues cited most often were 591-1-1-.26(4) Requires That Playgrounds Be Protected From Traffic or Other Hazards by a (4) Four Foot High Fence or Other Barrier Approved by This Department. Fencing Material Shall Not Present a Hazard to Children and Shall Be Maintained So as to Prevent Children From Leaving the Playground Area by Any Means Other Than Through an Approved Access Route. Fence Gates Shall Be Kept Closed Except Whe (2), 591-1-1-.12(2) Requires That All Equipment and Furniture Be Free From Hazardous Conditions Such As, but Not Limited To, Sharp Rough Edges or Toxic Paint (1), and 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. It Was Determined Based on Observation That One 8 Ounce Can of Great Value Air Freshener, One Bottle of Thirty Four Ounce Equate Moisturizing Hand Sanitizer, 1 Bottle of 7.5 Ounce Soaftsoap, and 1 Bottle of 16.9 Ounce Antibacterial Hand Soap Was Stored on the T (1). None of the 4 findings were critical.
