Across 4 inspections since 2024, the issues cited most often were 591-1-1-.08(1) Requires the Center Staff to Maintain a File for Each Child While Such Child Is in Care and for One Year After That Child Is No Longer Enrolled. In Order for the File to Be Complete, the File Shall Contain the Following: Child's Name, Birth Date, Sex, Address, Living Arrangement, Name of School if Applicable (2), 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. It Was Determined Based on Observation the Following Hazards Were Accessible to Children: -Wipes Packages on Diapering Table- 2L Classroom -Plastic/grocery Bags in Two Children's Cubbies- 2R Classroom (1), and Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities.
