Across 3 inspections since 2025, the issues cited most often were Associated with Complaint 591-1-1-.25(3) Requires the Center and Surrounding Premises to Be Kept Clean, Free of Debris and in Good Repair. Hygienic Measures Such As, but Not Limited To, Screened Windows and Proper Waste Disposal Procedures Shall Be Utilized to Minimize the Presence of Rodents, Flies, Roaches and Other Vermin at the Center. It Was Determined Following Inspection, Mold Was Detected (1), Associated with Complaint 591-1-1-.30(1)(a)3 Requires That Each Crib Shall Have Only an Individual, Tight-fitting Sheet Which Is Changed Daily or More Often as Needed and Prior to a Change of Occupant. It Was Determined Based on Investigation, a 9- Month-old Child Was Placed in a Crib Without a Crib Sheet Present Due to It Not Being Dried at the Time. (1), and Associated with Complaint 591-1-1-.11(2) Requires That Personnel Not: Physically or Sexually Abuse a Child or Engage or Permit Others to Engage in Sexually Overt Conduct in the Presence of Any Child Enrolled in the Center (1). None of the 5 findings were critical.
