Across 3 inspections since 2023, the issues cited most often were Associated with Complaint 591-1-1-.11(2) Requires That Personnel Not: Physically or Sexually Abuse a Child or Engage or Permit Others to Engage in Sexually Overt Conduct in the Presence of Any Child Enrolled in the Center (2), Associated with Complaint 591-1-1-.18(12) Prohibits Children From Being in the Kitchen Except as Part of a Planned, Supervised Learning Experience. It Was Determined on January 16, 2024, and January 24, 2024, Center Staff Allowed a Five-year-old Child Access to the Kitchen Without Permission While the Kitchen Door Was Open. (1), and Associated with Complaint 591-1-1-.07(2) Requires That Parents Be Immediately Notified and Specific Instructions Obtained Until the Child Can Be Picked Up or Returned to the Group, Immediately When Professional Medical Attention Is Required, or When the Child Experiences Symptoms of Moderate Discomfort, or When the Child Is Involved in an Incident That Puts Their Health And/or Safety at Risk and T (1).
