It Was Determined Based on Observation That There Were 10 Children in Room M-2nd Floor-School Age That Was Licensed for 7 Children. There Was No Incident or Injury. (1), Associated with Complaint 591-1-1-.11(2) Requires That Personnel Not: Physically or Sexually Abuse a Child or Engage or Permit Others to Engage in Sexually Overt Conduct in the Presence of Any Child Enrolled in the Center (1), and Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities.
