Across 3 inspections since 2025, the issues cited most often were 591-1-1-.08(2) Requires Center Staff to Maintain a File for Each Child That Includes Evidence of Age-appropriate Immunizations or a Signed Affidavit Against Such Immunizations for Each Child Enrolled in the Center on a Form Approved by the Department, and to Allow No Child to Continue Enrollment in the Center for More Than Thirty (30) Days Without Such Evidence. It Was Determined Based on a Review (1), Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (1), and 591-1-1-.26(6) Requires That Playground Equipment Provide an Opportunity for the Children to Engage in a Variety of Experiences and Shall Be Age-appropriate. For Example, Toddlers Shall Not Be Permitted to Swing in Swings Designed for School-age Children. The Outdoor Equipment Shall Be Free of Lead-based Paint, Sharp Corners and Shall Be Regularly Maintained in Such a Way as to Be Free of Rust And (1). None of the 5 findings were critical.

Between Each Diaper Change, the Diaper Changing Surface Shall Be Cleaned with a Disinfectant and Dried with a Single-use Disposabl
