Across 3 inspections since 2024, the issues cited most often were 591-1-1-.26(6) Requires That Playground Equipment Provide an Opportunity for the Children to Engage in a Variety of Experiences and Shall Be Age-appropriate. For Example, Toddlers Shall Not Be Permitted to Swing in Swings Designed for School-age Children.
