Across 4 inspections since 2024, the issues cited most often were 591-1-1-.15(1) Requires That Meals and Snacks Are Served, with Serving Sizes Dependent Upon the Age of the Child, That Meet Nutritional Guidelines as Established by the United States Department of Agriculture Child and Adult Care Food Program. Meals and Snacks Shall Be Varied Daily, and Additional Servings of Nutritious Food Shall Be Offered to Children Over and Above the Required Daily Minimum, I (2), Associated with Complaint 591-1-1-.11(2) Requires That Personnel Not: Physically or Sexually Abuse a Child or Engage or Permit Others to Engage in Sexually Overt Conduct in the Presence of Any Child Enrolled in the Center (1), and 591-1-1-.14(2) Requires a Staff Member Who Is Trained in CPR and First Aid to Be on the Premises and on Any Field Trip Whenever Any Child Is Present. In Addition, Staff Who Provide Direct Care to Children Must Satisfactorily Obtain Certification in First Aid and CPR by December 29, 2016 if Employed Prior to September 30, 2016 and Within 90 Days of Their Hire Date if Employed After September 30, 20 (1). None of the 5 findings were critical.
