Across 1 inspection since 2025, the issues cited most often were 290-2-3-.07(8) Requires the Home to Maintain for the Provider and Any Provisional Employee or Employee with Direct Care Responsibilities Current Evidence of Successful Completion of a Biennial Training Program in Cardiopulmonary Resuscitation (CPR) and a Triennial Training Program in First Aid Which Have Been Offered by Certified or Licensed Health Care Professionals or Trainers and Which Dealt With (2), 290-2-3-.08(1) Requires the Home to Have a Current and Updated Record for Each Child in Care and for a Period of One (1) Year After Each Child Leaves. Such Records Shall Include: Identifying Information (Child's Name, Birth Date, Parent's Name, Home and Business Addresses, Telephone Numbers) (1), and 290-2-3-.10(6) Requires the Home to Provide a Menu Listing All Meals and Snacks to Be Served During the Current Week.
