Across 4 inspections since 2024, the issues cited most often were Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (3), Associated with Complaint 591-1-1-.26(8) Requires Climbing and Swinging Equipment to Have a Resilient Surface Beneath the Equipment and the Fall Zone From Such Equipment Must Be Adequately Maintained by the Center to Assure Continuing Resiliency. It Was Determined Based on an Investigation That the Resilient Surfacing in the Fall Zone of the Play Structure on the Preschool–School-Age Playground Me (1), and 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. It Was Determined Based Upon Observation That There Was One Spray Bottle of Clorox Cleaner, One Can of Great Value Disinfectant Spray, and One Container of Great Value Disinfectant Wipes in an Unlocked Cabinet Under the Handwashing Sink in Classroom 1L. (1). None of the 5 findings were critical.
