Across 3 inspections since 2025, the issues cited most often were 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. It Was Determined Based on Observation That the Following Hazardous Items Were Accessible to Children: -Main Bldg Room 1L - A Draw Marked Teacher Supplies Was Not Locked and Contained Scissors, a Tape Dispenser, a Stapler and a Bottle of White Out. - Main Bldg (2), 591-1-1-.26(4) Requires That Playgrounds Be Protected From Traffic or Other Hazards by a (4) Four Foot High Fence or Other Barrier Approved by This Department. Fencing Material Shall Not Present a Hazard to Children and Shall Be Maintained So as to Prevent Children From Leaving the Playground Area by Any Means Other Than Through an Approved Access Route. Fence Gates Shall Be Kept Closed Except Whe (2), and 591-1-1-.30(1)(b)1 Requires That Cots and Mats Are of Sound Construction and of Sufficient Size to Accommodate Comfortably the Size and Weight of the Child (1). None of the 5 findings were critical.
