It Was Determined Based on Observation That the Following Hazards Were Present: - Main Room B: A Mop/mop Bucket Located Near Entrance to Classroom and Within Reach of the Children - Main Room D (Pre-K): Broom and Dust Pan Located Near Entrance to Classroom And (2), Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child.
