Across 2 inspections since 2024, the issues cited most often were 591-1-1-.25(3) Requires the Center and Surrounding Premises to Be Kept Clean, Free of Debris and in Good Repair. Hygienic Measures Such As, but Not Limited To, Screened Windows and Proper Waste Disposal Procedures Shall Be Utilized to Minimize the Presence of Rodents, Flies, Roaches and Other Vermin at the Center. It Was Determined Based on Observation the Ceiling Vents in the Bathrooms of the Two (1), 591-1-1-.10(4) Requires That if Diapers Are Changed on a Diaper Changing Surface, the Surface Shall Be Smooth, Nonporous, and Equipped with a Guard or Rails to Prevent Falls. Between Each Diaper Change, the Diaper Changing Surface Shall Be Cleaned with a Disinfectant and Dried with a Single-use Disposable Towel.
