Across 3 inspections since 2025, the issues cited most often were 591-1-1-.26(6) Requires That Playground Equipment Provide an Opportunity for the Children to Engage in a Variety of Experiences and Shall Be Age-appropriate. For Example, Toddlers Shall Not Be Permitted to Swing in Swings Designed for School-age Children. The Outdoor Equipment Shall Be Free of Lead-based Paint, Sharp Corners and Shall Be Regularly Maintained in Such a Way as to Be Free of Rust And (2), 591-1-1-.12(1) Requires Each Employee and Child in Attendance to Use All Indoor and Outdoor Furniture, Activity Materials, and Equipment in a Safe and Appropriate Manner and in Accordance with the Manufacturer's Instructions, Recommendations, and Intended Use. All Equipment and Furniture Shall Be Used Only by the Age- Appropriate Group of Children. It Was Determined Based on Observation That 1 6-m (1), and 591-1-1-.15(2)(f) Requires That Food for Infants or Children Less Than One (1) Year of Age Be Cut Into Pieces One- Quarter Inch or Smaller and Food for Toddlers Shall Be Cut Into Pieces One-half Inch or Smaller to Prevent Choking. It Was Determined Based on Observation That 4 1-year-old Children Were Served Whole Ritz Crackers That Were Larger Than 1 Half Inch Size. (1). None of the 5 findings were critical.
