Across 2 inspections since 2025, the issues cited most often were 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. It Was Determined Based on Observation in the Room Cafe the Tan Cabinet to the Left of the Entrance Doors Was Unlocked and Had First Aid Supplies Located on the Bottom Shelf. Additionally, the Small Table on the Left Wall of the Cafeteria Had an Open Container (2), 591-1-1-.08(1) Requires the Center Staff to Maintain a File for Each Child While Such Child Is in Care and for One Year After That Child Is No Longer Enrolled. In Order for the File to Be Complete, the File Shall Contain the Following: Child's Name, Birth Date, Sex, Address, Living Arrangement, Name of School if Applicable (1), and 591-1-1-.26(4) Requires That Playgrounds Be Protected From Traffic or Other Hazards by a (4) Four Foot High Fence or Other Barrier Approved by This Department. Fencing Material Shall Not Present a Hazard to Children and Shall Be Maintained So as to Prevent Children From Leaving the Playground Area by Any Means Other Than Through an Approved Access Route.
