Across 4 inspections since 2024, the issues cited most often were 591-1-1-.19(1) Requires a Center to Provide 35 Square Feet of Usable Space per Child, Which Will Determine the Center's License Capacity. It Was Determined Based on Observation That a Ratio of 2:27 Was Present in School Age Room 7 When the Capacity of 35 Square Feet Was Nineteen. (1), 591-1-1-.26(9) Requires the Playground to Be Kept Clean, Free From Litter and Free of Hazards, Such as but Not Limited to Rocks, Exposed Tree Roots and Exposed Sharp Edges of Concrete.
